Bye-Laws

The Rules and Regulation of the Past Students Educational Association
Shall be as under:

I NAME:

The name of association shall be "Past Students Educational Association"
Shri Sangameshwar Arts, Commerce (UG&PG), BCA and BSW College, Chadchan.

II OFFICE:

The office of the Association shall be situated at the premises of the college.

III OBJECTIVES:

The main objectives of the association shall be to spread secular education, which includes the following.

- 1) The member shall have an opportunity of being in touch with this alma mater.
- 2) Association shall conduct seminars, discussion, debates, industrial visits etc. and the member can take the benefits being a participant.
- 3) It shall act as an employment information bureau for the benefits of its members.
- 4) It can introduce the scheme of awarding scholarship and prizes to the meritorious and deserving students of the college and to conduct educational, social, general and other activities and programs and to publish books and news papers.
- 5) It shall conduct entertainment programs.
- 6) It shall extend any possible help to the mother institution.
- 7) It shall raise funds for the association.
- 8) It shall undertake any other educational and cultural activities supplementary to above objectives.

IV DEFINITION:

Unless otherwise repugnant the following words shall mean:

1. College: Shri Sangameshwar Arts, Commerce(UG&PG), BCA and BSW College, Chadchan-586 205.
2. The past students educational association: Past students educational association of Shri Sangameshwar Arts, Commerce (UG&PG), BCA and BSW College, Chadchan-586 205.

3. President: The president of the association.
4. Secretary: The Secretary of the association.
5. The Board: The Board of management, duly elected as per the rules and regulations of this Association.
6. Year: Year commencing from 1st April to 31st March.

V FUNDS:

The funds of the association can be raised by the following means:

- Subscriptions.
- Donations.
- Grants.
- Loans and
- Any other lawful means.

VI MEMBER:

- a) From the students: The students who have studied at least for one year in the college and pays the membership fees shall be enrolled as a "Member".
- b) From the staff: The Principal and any one of the staff member (teaching) shall be enrolled as the privileged members.

VII KINDS OF MEMBERS:

- A) 1) Privileged members: Principal and one of the staff member (teaching) of ,
Shri Sangameshwar Arts,Commerce(UG&PG),BCA and BSW College Chadchan-586
205.
- 2) Patron Member: The student who pays Rs.1100/- or /and more in one lump sum.
- 3) Life Member: The student who pays Rs.500/- in one lump sum or in not more than
three installments.
- 4) Ordinary member: The student who pays Rs.200/- in one lump sum.
- B) Every member shall have to pay Rs.200/-as registration fee for enrollment of his
name in the association.

VIII CANCELLATION OF MEMBERSHIP:

Any life member can be dismembered on any ground by the absolute majority of the members present in the general body meeting.

IX CONSTITUTION OF BOARD OF MANAGEMENT:

- a) The board of management shall consist of ten members (Exclusive of Privileged member ie.Principal) be elected at every 3 years as under:
 1. Vice-President. 2. Secretary. 3. Jt. Secretary.
 - 4) Treasurer. 5. Jt. Treasurer. 6. Five to be elected by life members.

Addition: All office bearers shall be elected from privileged/ patron/ life members.

- b) Addition: A member of the association who has worked as director for two years is eligible to become either secretary or treasurer.

X POWERS:

- 1) President: He shall preside over the annual general body meeting and board meeting.
- 2) Vice- President: He shall act in the absence of the President.
- 3) Secretary: He shall look after the daily working of the association in consultation with the president and shall particularly look after:
 - a) *The correspondence of the association,*
 - b) *Convening the meeting.*
 - c) *Any other incidental works in connection with working of the association.*
- 4) Joint Secretary: He shall act in the absence of the secretary and shall assist the Secretary in discharging his duties.
- 5) Treasurer: He shall look after the maintenance of accounts and registers.
- 6) Joint Treasurer: He shall act in the absence of the Treasurer and assist The Treasurer in discharging his duties.

XI MEETINGS:

1. The first general body meeting shall be called within 18 months of its date of inauguration.
2. The subsequent general Body Meeting shall be called at least once in Calendar year and not later than 15 months of its preceding General Body Meeting.
3. At least three board meetings shall be held in a year and the interval between the two meetings shall not be more than six months.
4. The special board meeting shall be called on request of not less than one third of the members of the board or three board members whichever is less.
5. Extraordinary meeting shall be called either by the President or Secretary on written requisition made by at least 50 members or the resolution made by the board.
6. Secretary of the governing body of Shri Sangameshwar Arts & Commerce, (UG & PG), BCA & BSW College, Chadchan shall be the permanent invitee at the board meeting, general body meeting and extraordinary meetings.

XII APPOINTMENTS:

1. Principal, Shri Sangameshwar Arts & Commerce, (UG & PG), BCA & BSW College, Chadchan shall always be the president of the Association.

2. The office bearers and directors shall be elected by a simple majority in general body meeting for every three years and they are eligible to be re-elected for any number of times in their life-time.
3. Causal vacancies of board members and the auditor shall be filled up by the board by a resolution passed at a meeting and the person so appointed will continue till the time of the original incumbent would have continued.
4. The remuneration of the employees of the association shall be fixed by the board.

XIII APPOINTMENTS OF SUB COMMITTEES:

1. The board is authorized to constitute the Sub-Committees for any specific works.
2. Sub-Committees are accountable to the Board and the Board is accountable to the general body.

XIV QUORUM:

1. Board meeting: three members can constitute the quorum for the meeting.
2. General body meeting: 1/3rd of the total members or 10 members in person whichever is less shall make the quorum.










XV POWER OF THE GENETRAL BODY:
